## **ANNUAL GENERAL MEETING**

Minutes: Annual General Meeting held Saturday, January 24, 1970 at the Capri Motel, Red Deer, Alberta. The meeting started at 2:00 p.m. with Wilbur Freeland, President, presiding.

The minutes of the last Annual General Meeting were read by the Secretary, Jim Ramsay. It was moved by Izzy Gliener and seconded by Marjorie Cowie, that the minutes be adopted. Passed.

Reports were then received from all Committees of the School.

## **CLASSES COMMITTEE**

Edmonton. Izzy Gliener reported that 20 students were graduated from the 28-week course in the spring of 1969. The fall classes, though small in number - 8 students - were successful, and new

classes will begin at the end of January.

Calgary. Jim Ramsay reported that there were 40 graduates of the 28-week course in the spring of 1969, and that 46 are presently enrolled in the 28-week course.

He further advised that the New York School had sent some material entitled "Useful Economics", by Col. E.C. Harwood, published by the American Institute for Economic Research, Great Barrington, Massachusetts, for assessment by us. Gaye Shaw had prepared an evaluation of it for the meeting. She reported that it covers all the material we cover in the first 10 sessions using completely new terms, and includes a section on the money concept. She reported "It is pretty strong, no watered-down version, and could possibly be used as a replacement for the present lesson material".

John Alston asked whether this would have greater appeal for the younger students. Izzy Gliener wished to have copies to try out on an experimental basis in Edmonton. Gerry Shaw suggested that this could be used for the basis of a shorter course than the regular 28-weeks. Don Freeland suggested that 50 copies of the material be obtained for perusal by all the directors and other interested parties.

There was also discussion of lesson material received from the Detroit school that could possibly be used in a shorter course.

#### MEETINGS COMMITTEE

Edmonton. A regular monthly meeting of past graduates is being held and attendance is growing slowly but steadily to what is hoped will be a successful total. Topics for the meetings are varied and interesting and good participation is being obtained. There is an enthusiastic core of good people in Edmonton and the future is very bright.

Calgary. Jack Marles, the chairman, advised that meetings had been held monthly since April, 1969, including a School picnic in July and a Christmas party in December. All meetings till October had been Internal, that is the speakers were all from within the group. The first External meeting was in October when the guest speakers were, Len Werry (P.C.) MLA, Calgary-Bowness, and Rev. Bob Simpson (S.C.) MLA, Calgary North. The November meeting with a panel on Housing received good advance publicity in the newspapers and a TV news interview was filmed at the meeting. At the January meeting a survey was taken and members were given

the opportunity to evaluate past meetings and advise on their preference of topics for future meetings. These findings will form the basis of future programs.

#### COMMUNICATIONS COMMITTEE

Jim Ramsay, chairman, reported that things were proceeding normally, with the Newsletter going out monthly, and another Quest is now in the process of production.

Following the presentation of the brief to the Legislative Committee on Assessment and Taxation Gerry Shaw and Jim Ramsay have seen various Cabinet Ministers - Robert Clark, Minister of Education and Youth; Raymond Speaker, Minister of Social Development; Anders Aalborg, Provincial Treasurer; Gordon Taylor, Minister of Highways and Transport; Edgar Gerhart, Attorney General; Fred Colborne, Minister of Municipal Affairs and Arthur J. Dixon, Speaker of the House. Jim and Gerry reported that in the half hour interviews with each of these men they were able to get a lot of our views across and received a good reception. In Edmonton, Izzy Gliener and others have also been seeing MLA's and Cabinet Ministers and Izzy had just been advised that Mr. Colborne has placed discussion of the School's brief on the agenda of the Cabinet. Much is going on behind the scenes. Izzy also reported that the Members are asking for copies of the Tax Report that the Edmonton group have now in preparation re taxation. Chief Commissioner Peter Barga and Mayor Ivor Dent have requested that the Edmonton City Assessor Provide information to the Committee and this is being computerized and a report will be made to the Commissioner and the Mayor. This report will deal with a representative cross-section of property in Edmonton showing assessments, tax rates, market values, etc. Copies will be made available to school members when completed.

#### RESEARCH COMMITTEE

At the 1970 Conference many people will be looking to the Alberta School for information on Land Value Taxation in Alberta, and a committee is being formed to provide this information including Keith Laatsch, Derek Gould, John Alston and any other volunteers interested in this vital subject. Gerry Shaw spoke of the research he has been undertaking on the LVT aspects of the new Federal Parks policy in Banff and Jasper National Parks.

## FUND RAISING COMMITTEE

Gerry Shaw, chairman, reported that a letter had been sent out to all graduates soliciting membership in the School. So far there have been 17 replies and contributions of \$511.00. Since the letter went out before Christmas and could have been overlooked in the holiday festivities, a follow up is planned. Edna Holbrook asked whether enough publicity is being given about present activities to the past graduates so they would be aware of whatever progress is being made. Jim Ramsay advised that additional information along this line is being added to the Newsletter.

## TREASURER'S REPORT

After a short coffee break Gerry Shaw, Treasurer, submitted his report. (See copy attached). Jack Marles, who performed the audit explained the new receipt procedures to be adopted. It was moved by Gerry Shaw and seconded by John Also that the report be accepted. Carried.

## NEW BUSINESS

### Academic Advisory Council Appointment

Jim Ramsay reported that Professor Edwin Rose, of the University of Alberta, Edmonton, had been proposed by the Alberta School to be appointed to the Academic Advisory Council of the International Headquarters in New York City and this appointment has now been accepted by Prof. Rose and Confirmed by New York. He is a Professor of Literature and author of the book "Henry George", published by Twayne Publishing Company in their Great Americans Series.

### New Film

The Robt. Schalkenbach Foundation have a new film available entitled "Better Cities". At the moment all seven prints are booked but we hope to get a copy for showing in the Edmonton and Calgary districts in the spring.

### Single Tax Town

On behalf of Doug Clark, 6831 Livingstone Dr. S.W., Calgary 10, Ph. 242-3297, a current student, Jim Ramsay reported on the possibility of establishing a Single Tax Community in Alberta. The details are that Doug Clark and his family control five quarter

sections, five miles outside of Edmonton. And a friend has options on another 20 quarter sections, making a total of 6 1/4 sections. This land is optioned at from \$500. to \$1,200 per acre and there are 4,160 acres. Total purchase price would be between \$2 and \$5 million. At 5 lots to the acre, this would run between \$100. and \$240 per lot for the raw land. Particularly in view of Gerry Shaw's submission to the Legislature for permission for the individual communities to implement Land Value Taxation, and the relatively small amount of money needed to control this parcel - almost the size of a township - this might be a golden opportunity to establish a complete LVT satellite city. It could be started by selling bonds and debentures to raise funds needed to set up a corporation and eventually selling shares in the corporation to those who wish to build on the land.

Discussion on this followed in which John Alston spoke of how this could be done, that it could even be the place to implement a 'Finnish type' model community. However the present inflation might make this an inopportune time to proceed. John also advised that he would be willing to undertake further study on this. The idea was tabled for the present since it may possibly be outside the realm of the School's activities.

#### Office Equipment

Jim Ramsay requested permission to purchase an offset plate-maker which would assist in the preparation of the Quest and other school materials. The approximate cost will be between \$100 and \$150. Don Freeland moved to authorize the purchase of the plate-maker when the funds were available. It was seconded by Mike Underwood and carried.

#### President Urges Pledges to Balance the Budget

It was suggested by Wilbur Freeland that all members see the Treasurer and pledge what funds they could contribute. With some idea of income it would enable the new executive to set up a budget for 1970 and deal with future needs and expenditures on a more long-range basis.

#### 1970 Conference

Jim Ramsay then gave a report on the progress of the North American Conference of the Henry George Schools coming to Calgary this July 7th to the 12th. Suggested themes were "Nearer the

Margin" or "Advance and Consolidate". He outlined the activities planned, both business and social, and a tentative program will be circulated with a future Newsletter.

There was no further new business.

#### ELECTION OF OFFICERS FOR 1970

Wilbur Freeland then called for the presentation of a slate of candidates for office, but said he wished to resign as President. He said he has been president of the School since its inception and has been gratified by the growth of the school in that time. Although resigning as president he would be happy to continue as a director. Izzy Gliener voted special thanks and appreciation to Wilbur for his work and interest in the School. Jack Marles read the suggested slate and there being no further nominations offered from the floor it was moved by Richard Cowie and seconded by Edna Holbrook that the slate be adopted. AUDITOR'S REPORT

To the members of The School of Economic Science and Social Philosophy.

I have examined the balance sheet of The School of Economic Science and Social Philosophy as at December 31, 1969 and the Statement of Revenue and Expenditures for the year then ended. My examination included a general review of the accounting procedures and such tests of accounting records and other supporting evidence as I considered necessary in the circumstances, except that, in my opinion, the internal system of control with respect to cash receipts of the School has been inadequate during the year under review with the result that I have been unable to complete audit procedures deemed necessary to the verification of revenue.

Subject to the qualification set out in the preceding paragraph, in my opinion these financial statements present fairly the financial position of the society as at December 31, 1969 and the results of its operations for the year then ended, in accordance with generally accepted accounting principles applied on a basis consistent with that of the preceding year.

## FURTHER NEWS ON COMMUNICATIONS COMMITTEES

10

These committees of both the Edmonton and Calgary branches have been actively following up the School's submission (copy was attached to the October Newsletter) to the Special Legislative Committee on Assessment and Taxation with cabinet ministers and MLA's.

This work is all being carried out in the nature of an educational effort so it rightly is a function of the school. Since attempts are being made to expose representatives of all parties to our ideas we are maintaining our non-political position.

To date personal interviews have been held with the following ministers: Aalborg - Treasurer

Speaker - Social Development

Clark - Education

Colborne - Municipal Affairs

Taylor - Highways

Gerhart - Attorney General

Dixon - the Speaker

In addition the mayors of Calgary and Edmonton have been advised, by personal discussion, of the contents of our brief and the follow up action being taken with the MLA's.

Private discussions have also been carried on with Peter Lougheed (P.C. Leader - Calgary), Getty (P.C. - Edmonton), Hyndman (P.C. - Calgary) and Leavitt (S.C. - Calgary). Also Buckwell (S.C. - Fort MacLeod), Muller (S.C. - Westlake - Pembina), Russell (P.C. - Calgary) and Mayor Barnett of Red Deer were sitting members of the Special Committee on the 17th of October when our brief was verbally supported in Calgary.

Finally a copy of our brief has been sent with a covering letter to all ministers and MLA's that there has not been time or opportunity to make personal contact with.

In all cases of our personal discussions (except Calgary's mayor - who privately only has one vote) our members have been received with genuine interest. The approach has been to inform of the contents of our brief and to ensure that it is understood that

our proposed amendment could not disrupt any current policies or regulations such as the Education Foundation Plan. The basic economic justification for shifting the tax emphasis has been discussed, and where applicable, additional reports and data to support the concept of site value taxation or explaining its present day applications have been given to those elected representatives. Finally in all cases it has been stressed that nothing could be accomplished at the municipal level until the provincial law is changed.

Some direct evidence (letters) and indirect (conversation) has been received that indicates that the idea of permissive legislation to untax improvements will be receiving careful consideration by the provincial cabinet. It appears that it is realistic to hope that the matter will be brought before the legislature (house) in the not too distant future.

Appendix A and B are very interesting and well done. They deal quite clearly and concisely with competition and the principles of freedom. I believe the concepts of liberty and freedom are more closely defined and dealt with in a more comprehensive manner than the present class material.

CONCLUSION:

The whole text could be co-ordinated with our first 10 weeks as we now present them, or the areas in which Mr. Harwood's approach is especially superior could be used by themselves to supplement our material. I would strongly suggest using Chap. 7 and Appendix A and B at least.

## BOOK EVALUATION

Re: "Useful Economics" by Col. E.C. Harwood

Comments: Unique! Novel! Original! Good mental exercise!!

### Observations:

Although the author covers all the same material that we do in the first 10 weeks, some of it is introduced in such a subtle way, that it may not be impressed upon the student strongly enough, for instance; that the Margin of Production determines, Rent, Wages and Interest.

As "Useful Economics" is fairly recently published, it might make a very interesting complement to excerpts from Progress and Poverty, as several students show concern about studying something that was written so long ago.

The way the author introduces definitions for LAND, LABOR and CAPITAL is an interesting approach, and in a class I think the new terms could be related to the conventional ones quite easily.

Chapter 2 does point out the inconsistency of economists as far as terms are concerned, but in my opinion, the chapter may be too confusing to a new student.

Chapter 7 is extremely well done. Perhaps this chapter should be incorporated into our course, as the author deals with money, credit, banking, gold standard, inflation and revaluing currency in a far more comprehensive manner than the material used at present in the Calgary school.

With respect to the examples of modifications to private monopoly of land in New York, Pittsburg, Australia and New Zealand in Chapter 9; the examples are not stated consistently enough to allow the reader to compare the difference in the amount of wealth taken for the community.

The author drops all pretense of having come as a study group from Mars fairly early in the material, and the theme is not picked up again at the end. This is of no importance, but I think the Martians could have made some conclusive statement about the strange creature earth man and his approach to economics, and boarded the



# The Banff Controversy

Editor, The Herald:—

The federal government policy of increasing the rent on land in the national parks is receiving a good deal of attention and criticism. Perhaps the increase should have been phased in more gradually, or perhaps Mr. Chretien was rather arrogant in telling the people of the parks they were free to leave. However, an aspect that does not appear to have received too much attention is that the policy seems to have a good basis in economics.

The cost of owning land would be the interest on the money for which the land could be sold. That is, if a parcel of land can be sold for \$10,000, then the cost of retaining ownership would be the interest that could be realized from investing the \$10,000 elsewhere. With interest rates at around 9 per cent, this would be \$900 per year. The government is charging 6 per cent, or in other words, \$600 per year.

The policy of retaining ownership enables the government to obtain revenue without increasing the cost to individuals of exclusive possession of land. The government could increase rental rates to 9 per cent of the land value and still the cost of possession would not be greater than the cost of possession under outright ownership. This is revenue that does not have to be collected in taxes.

One wonders whether a policy of this kind would not work as well outside as inside the national parks. In any case, it would seem as if Mr. Chretien should be commended for the insight he has shown.

Thank you for news stories and editorials regarding the latest Banff controversy. Residents would, of course, be very pleased to prove they have the capability to operate their town. We could do much better, at less cost, than the present administration is doing.

There was one point which was not brought out as clearly as it should have been. There have been other proposals to increase the rents; they were all acceptable. We accepted increases proposed by the Crawford report, Hon. Walter Dinsdale, the national parks policy (1964 version), and we would gladly have accepted the findings of the Plunkett report had we been asked.

The appraisal conducted last summer does not treat businesses or residents equitably. The terms of reference must have directed the appraiser to work on permitted use of land, rather than actual use.

We cannot accept, nor should your readers, the practice of treating leases or lease terms in a secretive manner. These are public funds, and should be open to public scrutiny. There should be one standard (acceptable) lease, which should be available from the Crown only by means of public tender.
